That Change Order No. 1, dated June 28, 1978, heretofore filed with the City Clerk of said City as Document No. '764725, issued in connection with the contract between The City of San Diego and Gulf Electric Company of California, Inc., for STREET LIGHT CONVERSIONS - CONTRACT NO. 1, PHASE 1, PWEA OF 1976, TITLE II, said contract having been filed in the office of the City Clerk as Document No. 764176, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$29,688, and an extension of time of 30 working days extending the completion date to 150 working days, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$29,688 be hereby authorized out of Public Works Employment Act Fund 2682 of The City of San Diego, solely and exclusively, for the above stated purpose.
