


RESOLUTION No. 221848 (R-79-393)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$340,426.00 by T. B. PENICK AND SONS, INC., a corporation, and authorizing a contract for CONSTRUCTION OF ROLLING HILLS PARK AND TWIN TRAILS PARK, Base Bid, including Deductive Alternate 1 and 2, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 763412.
2. That the expenditures of \$31,562.00 from Park Service Fund 12140; \$141,957.00 from Park Service Fund 12141; \$69,020.00 from Park Service Fund 11141; \$54,775 from Park Service Fund 12145; and \$666.00 from Park Service Fund 11145 of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.




