

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the City Manager be, and he is hereby authorized and directed to execute, for and on behalf of The City of San Diego, agreements with Penasquitos, Inc. to provide for the receipt of prepaid park fees for subdivisions known as Penasquitos Bluffs Unit Nos. 11, 12, and 13, pursuant to Municipal Code, Section 102.0805 and Section 96.0403, under the terms and conditions of those agreements on file in the office of the City Clerk as Document Nos. 764766 and 764767, respectively.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and directed to execute, for and on behalf of The City of San Diego, an agreement with Penasquitos, Inc. and William Lyon Company to provide for receipt of prepaid park fees from Penasquitos, Inc. for the account of Penasquitos Bluffs Unit No. 8, pursuant to Section 96.0403 of the Municipal Code, and to provide for dispersal of subsequent fees paid by William Lyon Company to Penasquitos, Inc. as received, under the terms and conditions of the agreement on file in the office of the City Clerk as Document No. 764768.
