BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager of The City of San Diego hereby accepts the generous contribution of \$34,500 from Penasquitos, Inc., and directs that said contribution be deposited in Trust Fund 3021 to be used exclusively for the purpose of the development of Rolling Hills and Twin Trails Parks.

2. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Penasquitos, Inc. concerning the donation by Penasquitos, Inc. for the development of Rolling Hills and Twin Trails Parks, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. '764734.

3. That this Council does hereby commend Penasquitos, Inc. for this act of civic generosity and does hereby publicly express on behalf of the citizens of this City a debt of gratitude to this corporation.
