BE IT FURTHER RESOLVED, that the expenditures of \$1,336,600 and \$4,032,000 out of Fund 28652--CETA Title II Fiscal Year '79 and Fund 28663--CETA Title VI Fiscal Year '79, respectively, of The City of San Diego, be and they are hereby authorized, solely and exclusively, for the operation of the Public Service Employment Program.
