

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, a portion of Old Survey 57 (Black Mountain Road) has been relocated by the dedication on this date of a portion of Black Mountain Road within the subdivision to be known as Booth Subdivision; and

WHEREAS, those properties adjoining that portion of Old Survey 57 (Black Mountain Road) to be vacated will continue to have access or will be accessible by the street which has been dedicated on this date in the subdivision to be known as Booth Subdivision; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of Old Survey 57 (Black Mountain Road), as more particularly shown on Drawing No. 14141-B on file in the office of the City Clerk as Document No. 764703, which is by this reference incorporated herein and made a part thereof, be and the same is hereby ordered vacated.

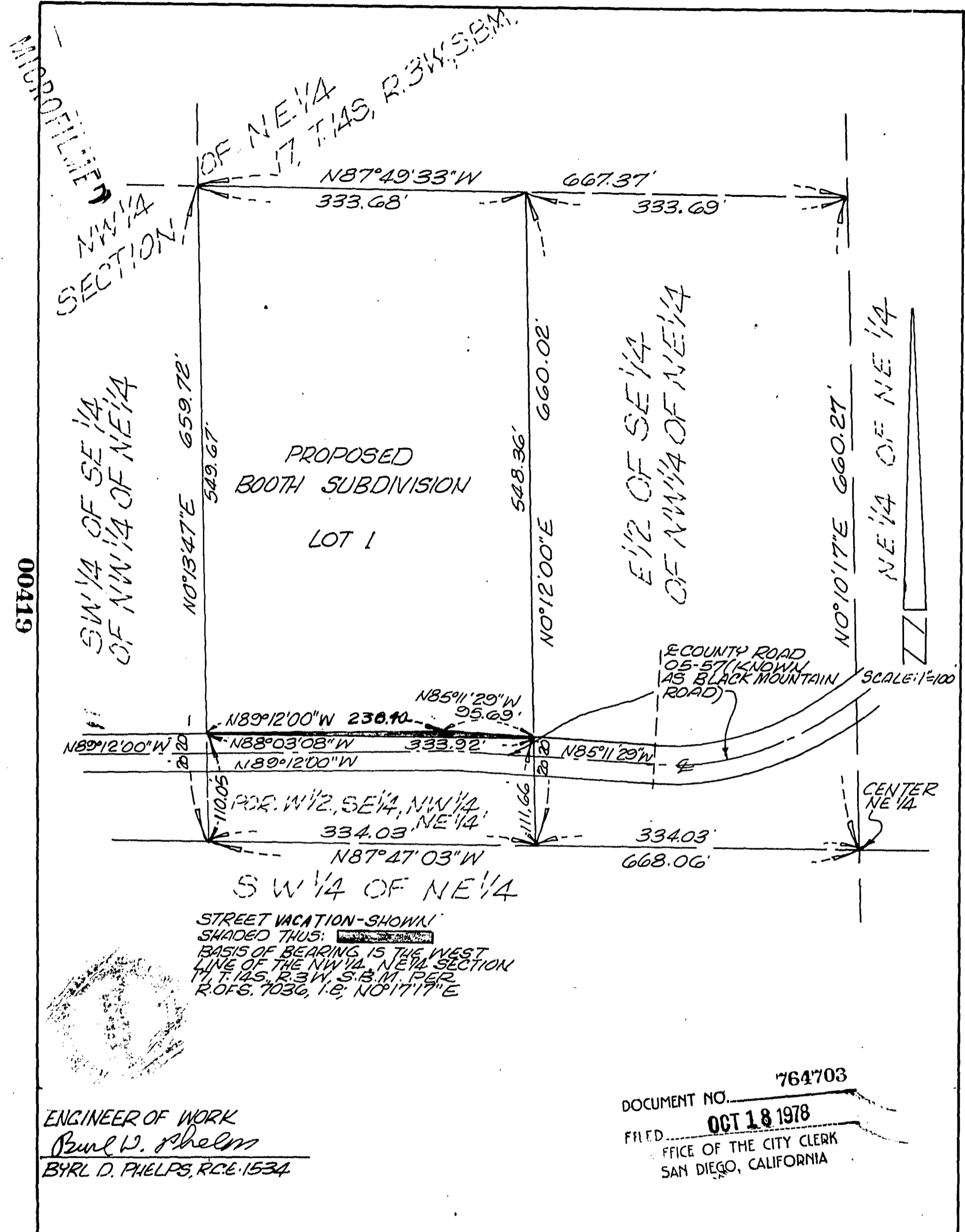
2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
