BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "HYDE PARK VILLAS Being a subdivision of a portion of Lot 395 of Lake Shore Unit No. 6, in the City of San Diego, County of San Diego, State of California, according to Map hereof No. 5131, filed in the office of the County Recorder of San Diego County, February 20, 1963; together with that portion of the Alley northerly of Hyde Park Drive adjacent to said Lot 395 on the west, vacated and closed to public use by the City Council of The City of San Diego by Resolution No. 180542, a copy of which was recorded July 10, 1964 as File No. 124743 Series 5, Book 1964 of Official Records, excepting from said portion of vacated Alley that portion thereof lying within the boundaries of Lot 1 of Lake Shore Unit No. 6,, Resubdivision No. 1, according to Map thereof No. 5453, filed in the office of the County Recorder of San Diego County, August 26, 1964.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


