

RESOLUTION No. 221911


Adopted on OCT -2 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those Street Easement Deeds of GAYLORD F. ARNOLD and BERNADETTE ARNOLD, husband and wife as joint tenants, and THOMAS B. MACK, JR., a single man and CARLOS FLORES, a single man, executed in favor of The City of San Diego, bearing dates of May 10, 1978 and May 22, 1978, respectively, conveying to said City an easement for a right of way for a public street and incidentals thereto over that portion of Lot 9, Map of Lots 61 and 62 and easterly portions of Lot 63, Rancho Mission, Map No. 1550, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named FONTAINE STREET.

That the City Clerk is hereby authorized and directed to deliver said deeds and a certified copy of this resolution to the Engineering and Development Department for further handling.
