That the acceptance by the City Manager of that Street Easement Deed of LAS CUMBRES PROPERTIES, executed in favor of The City of San Diego, bearing date of July 12, 1978, conveying to said City an easement for public street purposes over, along and across all that portion of Pueblo Lot 1103 of the Pueblo Lands of San Diego, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named VIA LAS CUMBRES.
