

RESOLUTION No. 221920 (R.79-465)


Adopted on OCT -2 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Easement Deed of FRANK S. and ADELINA G. ROSA, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of July 31, 1978, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across those portions of Lot A-78 and the unnumbered lot lying northerly of and contiguous to said Lot A-78, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named SOUTH VISTA AVENUE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.
