

RESOLUTION No. 221931

Adopted on OCT 2 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF ONE HOUR, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following street in said City:

Both sides of Prospect Street between Girard Avenue and Cave Street.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, that the portion of Resolution No. 10477 dated December 18, 1975, establishing a parking time limit of two hours on both sides of Prospect Street, between Ivanhoe Avenue and Cave Street, be and it is hereby rescinded.

BE IT FURTHER RESOLVED, that the portion of Resolution No. 74637 dated July 15, 1941, establishing a parking time limit of two hours on Prospect Street, between Girard Avenue and Ivanhoe Avenue, be and it is hereby rescinded.
