WHEREAS, there has been an increasing safety problem on State Route 163 through Balboa Park created by the close proximity and substandard on-ramps to the freeway from Richmond Street and Quince Street; and

WHEREAS, CalTrans has requested that these two ramps, as well as the off-ramp from Route 163 to Quince Street, be closed for six months during which time CalTrans will monitor and study the closing impact before determining if the ramps should be permanently closed; and

WHEREAS, it is in the interest of the public health, safety and welfare that said ramps be temporarily closed; NOW, THEREFORE,

BE IT RESOLVED, that pursuant to Section 21101(e) of the Vehicle Code of the State of California the closing of the on and off-ramps at Quince Street and State Highway Route 163 (Cabrillo Freeway), and the on-ramps from Richmond Street to State Highway Route 163 for a six month period to be determined by the Department of Transportation of the State of California is hereby approved.

BE IT FURTHER RESOLVED, that said closing shall be accomplished by personnel of the State Department of Transportation and that the cost to implement the closure and for observation and study shall be borne by the State of California.
