
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a representative from the City Attorney's Office is hereby authorized to travel to Washington, D.C., during the period October 8 through 10, 1978, to participate in the oral argument before the U.S. Supreme Court concerning the allocation of Colorado River waters to certain Indian tribes in the Colorado Basin as a result of the decision in Arizona v. California.

BE IT FURTHER RESOLVED, that the expenditure of \$600 is hereby authorized out of Water Utilities Operating Fund 500 (61.10) for the sole and exclusive purpose of providing funds for lodging, travel and miscellaneous expenses.
