

RESOLUTION NO. 221939 (R.79-544)

WHEREAS, The City of San Diego is the owner of Lot 8, Research Park Subdivision Addition; and

WHEREAS, said land has been determined to be surplus to all City needs; and

WHEREAS, the City desires to negotiate the sale of said land to the highest bidder at the October 2, 1978 auction, under the provisions of Section 22.0902 of the San Diego Municipal Code; and

WHEREAS, said land is listed in the City's Real Property Marketing Catalog (Page No. 222); and

WHEREAS, the value of the property to be conveyed by the City, as determined by an Independent Fee Appraisal, is the sum of Three Hundred Forty Eight Thousand Five Hundred Dollars (\$348,500); and

WHEREAS, a ~~an~~ real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That that certain real property described in that grant deed on file in the office of the City Clerk as Document No. 764761, be, and the same is hereby authorized to be sold to the highest bidder at the October 2, 1978 auction, for the sum of \$700,000.



3. That ~~any~~ broker's commission shall be paid by The City of San Diego.

4. That the payment of related expenses in accordance with the sale from the proceeds thereof is hereby authorized.

5. That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
