

RESOLUTION NO. 221941

(R. 79-617)

WHEREAS, a tragic mid-air collision over North Park on September 25, 1978, claimed the lives of at least 150 persons; and

WHEREAS, an independent and objective investigation into the cause of the collision is an absolute necessity for the future safety of both air travelers and residents living under aircraft flight patterns; and

WHEREAS, the National Transportation Safety Board is expected to convene a public hearing in San Diego for the purpose of determining the cause of the collision; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That The City of San Diego desires to become a party to the hearing for the purpose of aiding in the complete disclosure of all relevant information and further that the City pledges its full cooperation in the conduct of the proposed hearing; and

BE IT FURTHER RESOLVED, that the City Attorney is directed to contact the Chairman of the Board of Inquiry conducting such a hearing to request that the Chairman, pursuant to Section 831.27 of Title 49 of the Code of Federal Regulations, designate the City of San Diego as a party to the hearing; and

BE IT FURTHER RESOLVED, that the City Attorney be authorized to appear before the Board of Inquiry of the National Transportation Safety Board to represent The City of San Diego in the hearing established pursuant to Subpart C of Part 831 of Title 49 of the Code of Federal Regulations to investigate the tragic accident and the City Attorney is further authorized to utilize appropriate City staff to assist him in the matter; and

BE IT FURTHER RESOLVED, that the expenditure of \$1,000 for any travel or other expenses incurred in connection with the hearing is hereby authorized from the General Fund Unallocated Reserve for the above purpose.
