WHEREAS, the City Council has previously authorized on October 12, 1977, by Resolution No. 219495 the commencement of eminent domain proceedings in City of San Diego v. Presidio Development Company, et al., in San Diego Superior Court Case No. 407539 for purposes of implementing what is commonly known as Crest Canyon Open Space Park project, and the funds necessary to acquire the real property necessary for said project have been previously authorized by City Council Resolution No. 217734 on February 16, 1977; and

WHEREAS, Presidio Development Company is the defendant in this action and is the fee owner of the property identified in the above lawsuit; and

WHEREAS, said defendant has agreed to accept the amount of \$385,000 as the total amount of just compensation for its claims and interests in the property; NOW, THEREFORE,

BE IT RESOLVED that said City Council hereby resolves and authorizes the following settlement of the above litigation:

- 1. That the City Council of the City of San Diego does hereby authorize the expenditure of \$385,000 as payment to defendant Presidio Development Company of just compensation for all its claims arising out of the City's acquisition of the property described in the complaint and all damage to the remainder, if any, including, but not limited to, severance damage and erosion damage; and
- 2. That the City Council of the City of San Diego authorizes the expenditure of \$360,852 from Fund 3720 for said payment; and
- 3. That the City Council of the City of San Diego authorizes the expenditure of \$24,148 from Subdivision Park Fee Fund 11191 for said payment; and
- 4. That the City Attorney is hereby authorized to prepare and execute on behalf of the City of San Diego all necessary legal documents required to accomplish the above settlement.
