BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$227,201.50 by T.B. PENICK & SONS, INC., a corporation, for CONSTRUCTION OF A RETAINING WALL ON THE WEST SIDE OF 54TH STREET, 600 FEET SOUTH OF UNIVERSITY AVENUE (STORM DAMAGE REPAIR), in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764150.
2. That the addition of CIP 52-268 (54th Street, 600 feet south of University Avenue Improvements) to the FY 1979 Capital Improvements Program is hereby approved.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$64,641.00 from the Capital Outlay Fund Unallocated Reserve (CIP 90-245) and \$209,781.00 from the Gasoline Tax Fund Unallocated Reserve (CIP 90-220) to CIP 52-268.


