

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$191,372.00 by SILBERBERGER ENGINEERS INC., a corporation, for THE IMPROVEMENT OF SAN DIEGO STADIUM EAST CHANNEL (MURPHY CANYON CHANNEL AND SAN DIEGO RIVER CHANNEL), STORM DAMAGE REPAIR in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764200.
2. That the addition of CIP 11-169 (San Diego Stadium East Channel - Improvements) to the FY 1979 Capital Improvements Program is hereby approved.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$231,254 from the Capital Outlay Fund Unallocated Reserve (CIP 90-245) to CIP 11-169.




