


**RESOLUTION No.** 221957 (R-79-530)





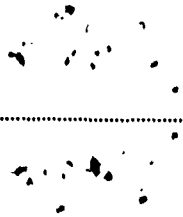
