


RESOLUTION No. 22195B (R-79-519)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$24,958.00 by SAPPER CONSTRUCTION CO., a corporation for THE IMPROVEMENT OF COAST BOULEVARD CURB AND SIDEWALK BETWEEN PROSPECT AND LA JOLLA COVE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764151.
2. That the addition of CIP No. 52-261 (Coast Boulevard, Prospect to La Jolla Cove, Improvements) to the FY 1979 Capital Improvements Program is hereby accepted.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$6,647.00 from Capital Outlay Fund Unallocated Reserve (CIP 90-245) to CIP 52-261, and \$27,011.00 from Gasoline Tax Fund Unallocated Reserve (CIP 90-220) to CIP 52-261.




