That that certain parcel of City-owned property located on the north side of Friars Road, west of Mission Village Drive encompassing approximately 20.5 acres, is hereby declared to be surplus and is designated for sale pending rezoning to possible commercial/recreation use.

BE IT FURTHER RESOLVED, that this designation is subject to review by the Community Planning Group and approval by the Planning Commission and resubmittal to the Transportation and Land Use Committee before December 31, 1978.

BE IT FURTHER RESOLVED, that that certain parcel of City-owned property on the north side of Friars Road, east of Mission Village Drive encompassing approximately six acres, is hereby designated for use as open space.
