That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

Fred W. Rueger	General Services	\$ 50	Mr. Rueger is an Electrician in the Buildings Division. He suggested that crank-up scaffold trailers should be covered. This is expected to extend the life of such equipment up to five years. Annual savings is expected to be \$1,050. This is a partial award pending a final 12-month review.
Lauren P. Cordova	City Auditor	\$ 50	Ms. Cordova is an Intermediate Typist. She suggested that one Job Order Number be used to charge all photocopying to in the Auditor's Office. This reduces the time it takes to process photocopy usage reports. Savings are estimated at \$844 annually. This is a partial award pending a final 12-month review.
Nina L. Ladd	Police Department	\$ 45	Ms. Ladd is a Senior Clerk. She suggested that photograph fee schedules in the Police Department be updated. This is expected to increase revenues by \$475 annually.
Gail F. Jeromin	Planning	\$ 20	Ms. Jeromin is a Zoning Representative. She suggested that fees for fence variances be increased. This is expected to increase revenues by \$180 annually.
