Dick Barickman	General Services	\$ 20	Mr. Barickman worked in the Mail Room. He suggested that a fisheye mirror be installed at a blind corner in the tunnel between the CAB and the COB. This is considered to be a significant safety improvement.
Paul D. Capps	Police	\$ 15	Mr. Capps is a Sergeant. He suggested that juveniles' birth dates be placed on the outside of arrest files. This is expected to save \$150 annually in the purging of juvenile files.
Linda M. Garfield	Park and Recreation	\$ 10	Ms. Garfield is an Intermediate Typist in the Community Services Division. One year ago, she earned a \$10 award for her idea to revise the event logging and scheduling form. This form has worked so well in the first year of operation that an additional award is warranted.
