BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a renewal lease agreement with WOODWARD SAND COMPANY, INC., as Lessee, for the purposes of extraction of sand, soil and gravel and construction of a flood control channel on a portion of Tract B, Rancho El Cajon, and for such other related or incidental purposes as may first be approved in writing by the City and for no other purpose, at an annual rental of \$6,000 for a term of five years, under the terms and conditions set forth in the form of said renewal lease agreement on file in the office of the City Clerk as Document No. 764840.
