WHEREAS, on the evening of September 9, 1978, an armed man wearing a ski mask entered a San Diego restaurant and brandished a handgun in an attempt to rob the establishment and its employees; and

WHEREAS, the victims were coerced at gunpoint to place money from the cash register and the safe into bags to be given to the offender; and

WHEREAS, during this moment of crisis, Robert Wilson, who is an eighteen-year-old employee, courageously confronted the would-be robber and though in fear of losing his life was able to physically stop the robber from leaving the store by wrestling him to the ground; and

WHEREAS, this display of quick action and heroic leadership by the selfless young man saved his fellow employees and the establishment from harm at great personal risk to himself; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that Robert Wilson be publicly commended for his outstanding performance; and

BE IT FURTHER RESOLVED, that this declaration of appreciation be made a part of the public record.
