

RESOLUTION NO. 222043

WHEREAS, the Department of Interior is proposing to lease 26 tracts of off-shore lands in the Dana Point-San Diego area as a part of Lease Sale No. 48 for exploration and production of oil and gas resources; and

WHEREAS, the oil and gas resources estimated for this area would provide a national consumption rate of only 36 hours for oil and 15.2 hours for gas; and

WHEREAS, the possibility of a 1000 BBL or greater oil spill impacting the San Diego shoreline as a result of the leases ranges from 5% - 20%; and

WHEREAS, adverse environmental considerations relating to air quality, seismic, biological, and socio-economic impacts of the proposed leasing have been identified; and

WHEREAS, these tracts, if unleased, could serve an important national reserve until such time as technology exists to safely utilize it; NOW, THEREFORE,

BE IT RESOLVED, that The City of San Diego hereby recommends to the Department of Interior and the California Coastal Commission that the twenty-six tracts between Dana Point and the International Border (Tracts 141 through 166) be withdrawn from Lease Sale No. 48.
