RESOLUTION NO. 222044 (R.79-339)

VACATION OF BRANT STREET ADJACENT TO LOT D,
BLOCK 321, AND LOT I, BLOCK 320, MAP 2163

WHEREAS, it is proposed that Brant Street adjacent to Lot D, Block 321, and Lot I, Block 320, Map 2163 be vacated; and

WHEREAS, there is no present or prospective use for the street either for the public street system for which the right-of-way was originally acquired or for any other public use of a like nature that can be anticipated in that the City has no need to preserve this right of way, as it is a dead-end facility which is not likely to be improved; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the right-of-way was originally acquired will not be detrimentally affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, California, that Brant Street adjacent to Lot D, Block 321, and Lot I, Block 320, Map 2163, as more particularly referred to in Resolution of Intention No. 221783, is unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that Brant Street adjacent to Lot D, Block 321, and Lot I, Block 320, Map 2163, as more

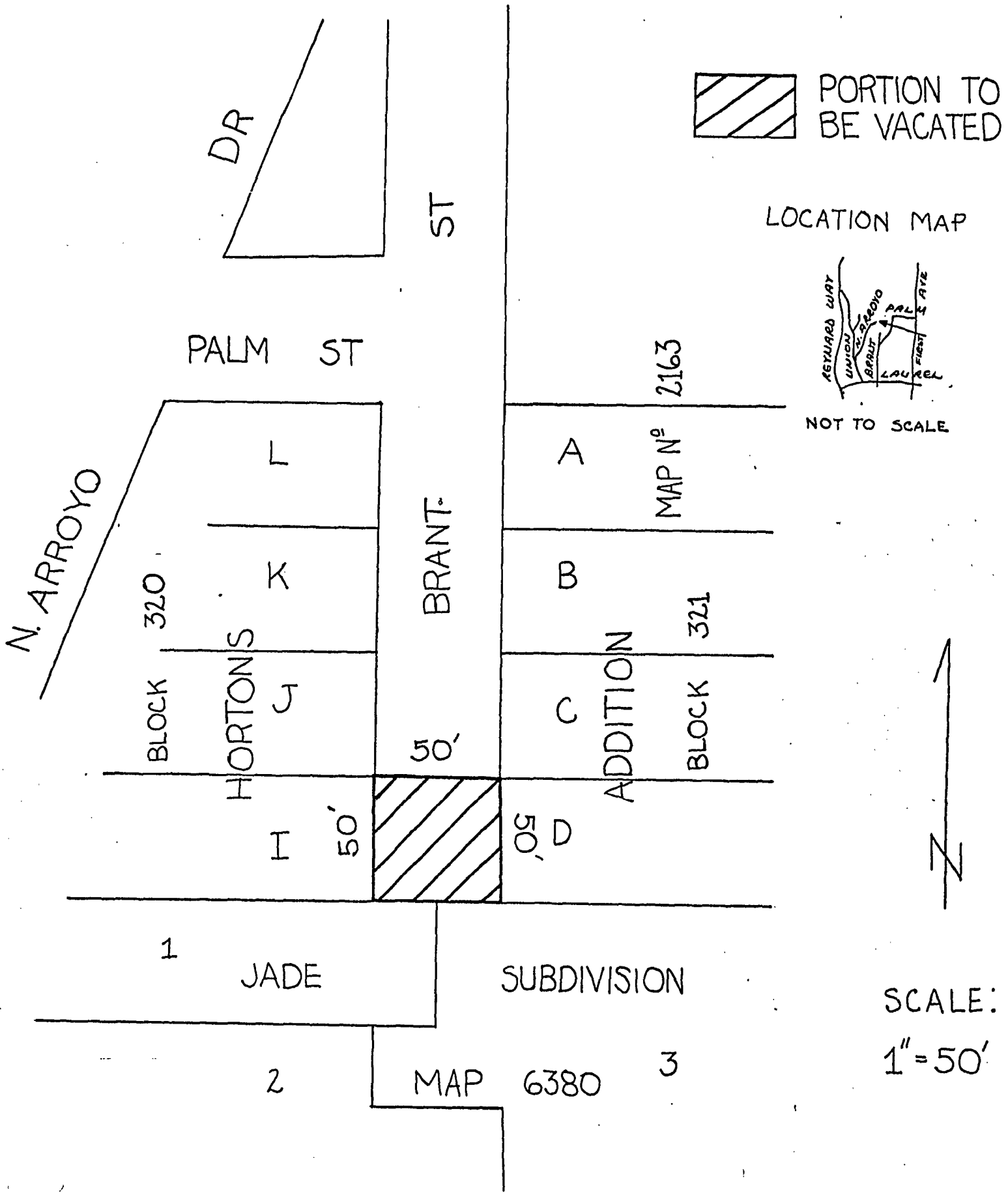
