WHEREAS, the Planning Commission held public hearings on September 14, 1978, to consider the PENASQUITOS EAST COMMUNITY PLAN (Alternative III-A modified); and

WHEREAS, the Planning Commission approved and recommended to the City Council adoption of the PENASQUITOS EAST COMMUNITY PLAN (Alternative III-A modified); and

WHEREAS, City Council Policy 600-7, requires that public hearings to consider revisions of the "Progress Guide and General Plan for The City of San Diego" shall be scheduled concurrently with all public hearings on proposed community plans; and

WHEREAS, the Planning Commission of The City of San Diego has held concurrent public hearings to consider the PENASQUITOS EAST COMMUNITY PLAN (Alternative III-A modified) and amendment of the General Plan in order to retain consistency between said plans; and

WHEREAS, on September 14, 1978, the Planning Commission adopted and recommended for adoption by the City Council an amended General Plan; and

WHEREAS, California Government Code, Section 65869, provides that mandatory elements of the General Plan may not be amended more than three times per year; and

WHEREAS, it is the intention of the City Council to consider amendments to the Progress Guide and General Plan for The City of San Diego at hearings conducted on a semiannual basis; and

WHEREAS, it is the intention of the City Council to conduct a public hearing on proposed actions that will result in changes to the Progress Guide and General Plan during the year, but such changes shall not become effective until enacted at the semiannual hearing conducted for the purpose of amending the Progress Guide and General Plan for The City of San Diego; and

WHEREAS, the Council of The City of San Diego held a public hearing to consider the PENASQUITOS EAST COMMUNITY PLAN (Alternative III-A modified); and


