R. 79-572

WHEREAS, California State law requires that each region in the State prepare a Transportation Plan; and

WHEREAS, the Comprehensive Planning Organization is preparing such a plan for the San Diego region; and

WHEREAS, the San Diego Regional Transportation Plan in accordance with State guidelines will contain a detailed Highway Element, including a description of the minimum Street and Highway System spanning the years 1978 to 1995; and

WHEREAS, such a plan is needed to serve anticipated population growth; and

WHEREAS, estimated revenues derived from the 7¢ State Gas Tax will diminish in future years due to the proliferation of more efficient vehicles resulting from Federal mandates; and

WHEREAS, estimated capital and operating costs to complete a minimum Street and Highway System far exceed State Gas Tax revenues; and

WHEREAS, continuing inflation and an inordinate increase in construction costs further erode the purchasing power of State Gas Tax revenues; NOW, THEREFORE,

BE IT RESOLVED, that the San Diego City Council urges the State Legislature to develop a realistic all inclusive highway plan to allow San Diego (as well as other State jurisdictions faced with similar future transportation funding straits), to
