BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$48,143.00 by D & H PERRY, INC. DBA PERRY ELECTRIC, a corporation, for CONSTRUCTION OF JOHN F. KENNEDY MEMORIAL PARK LIGHTING, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 763899.
2. That the expenditure of \$47,000 is hereby authorized out of Park Service Fund 11664, that the expenditure of \$12,600 is hereby authorized out of the Building Park Fee 15664 and that the expenditure of \$6,900 is hereby authorized out of the Capital Outlay Fund Reserve 245 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
