RESOLUTION NO. 222075 (R.79-660)

APPROVING MAP OF VILLA DOMINIQUE UNIT NO. 1
SUBDIVISION AND ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S
ASSURANCE OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING
PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by LEROY C. BODAS, Registered Civil Engineer, entitled "VILLA
DOMINIQUE UNIT NO. 1 Being a subdivision of a portion of
Lot 15 of Rosedale Tract, according to Map No. 825 filed in
the Office of the County Recorder of San Diego County, January 21,
1897, together with a portion of Lot D Portion Lot 70 of Rancho
Mission of San Diego, according to the Partition Map thereof
made in Superior Court Case No. 15191 of San Diego County, all
being in the City of San Diego, County of San Diego, State of
California.", is made in the manner and form prescribed by
law and conforms to the surrounding surveys; that said map and
the subdivision of land shown thereon is hereby approved and
accepted; and said Council hereby accepts on behalf of the
public, the following: Via Valarta, Via Dominique, Mayita Way,
Oporto Place, Oporto Court, Quito Court and Ocana Place for public
purposes, and said streets are hereby declared to be public streets
and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, the easements listed in
paragraphs 1 and 2 of the Owner's certificate, as shown on this
map and subject to the conditions set forth thereon.


