RESOLUTION NO.

A RESOLUTION MODIFYING RESOLUTION NO. 220205 ADOPTED FEBRUARY 1, 1978, BY RESCHEDULING THE DATE FROM SEPTEMBER 1, 1978 TO MAY 1, 1979 FOR REMOVAL OF ALL OVERHEAD UTILITY FACILITIES WITHIN THE INGRAHAM STREET (HORNBLEND STREET TO PACIFIC BEACH DRIVE) UNDERGROUND UTILITY DISTRICT.

WHEREAS, this Council did on February 1, 1978 by Resolution No. 220205 establish and designate July 7, 1978, as the date upon which all property within the INGRAHAM STREET (Hornblend Street to Pacific Beach Drive) UNDERGROUND UTILITY DISTRICT must be ready to receive underground utility service and September 1, 1978 as the date upon which all overhead utility facilities must be removed; and

WHEREAS, it has been determined to modify Resolution

No. 220205 by rescheduling the date from September 1, 1978 to

May 1, 1979 for removal of all overhead utility facilities within
the INGRAHAM STREET (Hornblend Street to Pacific Beach Drive)

UNDERGROUND UTILITY DISTRICT; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Resolution No. 220205 adopted February 1, 1978 be and it is hereby modified by rescheduling the date from September 1, 1978 to May 1, 1979 for removal of all overhead utility facilities within the INGRAHAM STREET (Hornblend Street to Pacific Beach Drive) UNDERGROUND UTILITY DISTRICT.



- 2. That the City Clerk is hereby directed to give notice to all affected persons as defined in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code and all affected utility companies of the adoption of this Resolution No. 222076 within fifteen (15) days after the date of such adoption. City Clerk shall specifically notify the affected persons that if they desire to continue to receive electric, communication, community antenna television or similar or associated service, they shall provide, at their own expense, all necessary facility changes on their premise so as to receive underground service from the lines relocated underground of the supplying utility company subject to applicable rules, regulations and tariffs of the respective utility company on file with the Public Utilities Commission of the State of California and subject to all other applicable requirements of State law and City ordinances. Clerk's notification shall be made in the manner provided in Chapter VI, Article 1, Division 5 of the San Diego Municipal Code.
- 3. The City Manager is hereby directed to give notice to such affected persons and affected utilities in accordance with Section 61.0511(b) of the San Diego Municipal Code.
