

RESOLUTION No. 222081 (R. 79-762)


Adopted on OCT 23 1978(REV)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and directed to report to the City Council within 90 days with input on a feasible site for relocating the Melville Klauber House and potential funding sources for the costs of relocation.

BE IT FURTHER RESOLVED, that the City Council hereby expresses its present intent to direct issuance of a demolition permit for the Melville Klauber House if, at the end of 90 days, the City Council has not approved a proposed means of relocating said structure.
