

1. The acceptance by the City Manager of a Grant Deed from Fotomat Corporation, a Delaware corporation, executed in favor of The City of San Diego, bearing date of September 29, 1978, conveying to said City the fee to Lot 25, City of San Diego Industrial Park, Unit No. 7, Map No. 6658, filed in the Office of the County Recorder on June 1, 1970, all as more particularly described in said deed, be and the same is hereby approved.
2. The sum of \$350,000 is hereby authorized to be paid out of the Capital Outlay Fund 245-1 (Industrial Development) to Fotomat Corporation for said property.
3. The City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the Office of the San Diego County Recorder.
