MAXWELL, INC., a corporation for the CONSTRUCTION OF A RETAINING WALL ON THE SOUTH SIDE OF TALBOT STREET BEGINNING 130 FEET EAST OF BANGOR STREET (STORM DAMAGE REPAIR) Base Bid and Alternate A in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 764370.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$16,850.00 from the Capital Outlay Fund Unallocated Reserve CIP 90-245 and \$135,280.00 from Gasoline Tax Fund Unallocated Reserve CIP 90-220 to CIP 52-264.
3. That the addition of CIP 52-264 (CONSTRUCTION OF A RETAINING WALL ON THE SOUTH SIDE OF TALBOT STREET, BEGINNING 130 FEET EAST OF BANGOR STREET (STORM DAMAGE REPAIR) to the FY 1979 Capital Improvements Program) is hereby authorized.
