BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the offer of Dunleavy & Associates is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of EIGHT (8) PORTABLE FIBREGLASS LIFEGUARD TOWERS at a cost of \$4220.00 each, terms 1% 30 days plus sales tax for a total cost of \$35,427.74.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$37,500.00 of Transient Occupancy Tax Facilities Reserve Special Revenue Fund 227 from C.I.P. 27-004 Ocean Beach Lifeguard Facilities to C.I.P. 27-005 Lifeguard Tower Improvements; \$35,000.00 of Capital Outlay Fund 245 from C.I.P. 27-005 Lifeguard Tower Improvements to C.I.P. 27-004 Ocean Beach Lifeguard Facility; and \$2500.00 from Capital Outlay Reserve Fund 90-254 (9) to C.I.P. 27-004 Ocean Beach Lifeguard Facility.
3. That the expenditure of \$37,500.00 is hereby authorized out of the Transient Occupancy Tax Facilities Reserve Special Revenue Fund 227 for this contract and related costs.




