
BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by BYRL D. PHELPS, a Registered Civil Engineer, entitled "KENDALL-
MIRAMAR BUSINESS PARK Being a division of the south half of the
Northeast Quarter of the Northeast Quarter of Section 11, Township
15 South, Range 3 West, San Bernardino Meridian, in the City of
San Diego, County of San Diego, State of California, together
with a portion of Trade Street as dedicated to public use.", is
made in the manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, the following: Kenamar
Drive and Formula Place for public purposes, and said streets are
hereby declared to be public streets and dedicated to the public
use.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map and that said
public streets are accepted on behalf of the public as heretofore
stated.

Said City Clerk is hereby directed to transmit said map to
the Clerk of the Board of Supervisors of the County of San Diego,
California.
