APPROVING MAP OF RIVERDALE GLEN SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by BYRL D. PHELPS, a Registered Civil Engineer, entitled "RIVERDALE GLEN Being a subdivision of Lots 1 to 20, inclusive and Lots 22 to 40, inclusive, of Blocks 8 and all of 9 and portions of Lots 1 through 20 of Block 7, together with the alleys in Blocks 8 and 9, Olympic Avenue (formerly Lincoln Avenue), Orcutt Avenue (formerly Logan Avenue) and portions of Riverdale Street (formerly Howard Street) and Fairmount Extension (formerly Howard Street) as dedicated to public use all of Grantville and outlots per the Amended Map thereof No. 776 recorded in the office of the County Recorder of San Diego County February 16, 1894 all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Friars Road and a portion of Riverdale Street for public purposes; and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement and right of way for the natural flowage of waters over, upon and across a portion of Lot 1 as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; and that the flowage easement as granted and shown on this map within this subdivision is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
