
A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF BERNARDO CENTER DRIVE IN BERNARDO GREENS WEST UNIT NO. 4 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.
