APPROVING MAP OF SOL-Y-MAR SUBDIVISION

OCT 31 1978

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, a Registered Civil Engineer, entitled "SOY-Y-MAR Being a subdivision of portions of Lots 5 and 6 of Pueblo Lot 1782, in the City of San Diego, County of San Diego, State of California, according to partition map thereof on file in the office of the County Clerk of said San Diego County in action entitled 'Ellen Treanor, et al, vs. San Diego Land and Town Company, et al,' Case No. 7634, lying easterly of the easterly line of La Jolla Mesa Drive as conveyed to the City of San Diego by C. W. Rodecker and Marjorie R. Rodecker, by deed dated October 20, 1929 and recorded in Book 1714, Page 54 of Deeds.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Skylark Drive, Baja Mar and a portion of La Jolla Mesa Drive for public purposes; and said streets and portion of a street are hereby declared to be public streets and portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any

and all abutters' rights of access in and to La Jolla Mesa Drive, adjacent and contiguous to Lot 8, as shown on this map within this subdivision; together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, all as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
