

RESOLUTION No. 222147 (R-79-802)

Adopted on NOV 6 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Norris Paint & Varnish Co., Inc. and 2. Pervo Paint Company are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of COLD APPLIED TRAFFIC PAINT for a period of two (2) years beginning December 1, 1978 through November 30, 1980 as follows:

1. Norris Paint & Varnish Co., Inc. for item 1 at a cost of \$4.17 per gallon, terms net 30 days plus sales tax; prices subject to escalation not to exceed 10% of bid prices, with an option to renew for an additional one year period during which prices are subject to an escalation not to exceed 5% of bid prices.

2. Pervo Paint Company for item 2 at a cost of \$4.45 per gallon, terms 1% 30 days plus sales tax; prices subject to an escalation not to exceed 15% of bid prices, with an option to renew for an additional one year period during which prices are subject to escalation not to exceed 15% of bid price.
