APPROVING MAP OF BERNARDO INDUSTRIAL PARK
WEST SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by LEO H. BARBOUR, a Registered Civil Engineer, entitled
"BERNARDO INDUSTRIAL PARK WEST Being a subdivision of Parcel 3,
in the City of San Diego, County of San Diego, State of
California, according to Parcel Map No. 5404 filed in the office
of County Recorder of San Diego County December 20, 1976.", is
made in the manner and form prescribed by law and conforms to
the surrounding surveys; that said map and the subdivision of
land shown thereon is hereby approved and accepted; and said
Council hereby accepts on behalf of the public, the following:
a portion of Camino Del Norte and a portion of Bernardo Center
Drive for public purposes; and said portions of streets are
hereby declared to be portions of public streets and dedicated to
the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation, the
easements with the right of ingress and egress for the installa-
tion and maintenance of drainage and sewer easements, and slopes,
as granted and shown on said map and subject to the conditions
set forth thereon.


