APPROVING MAP OF FASHION VALLEY NORTH SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM GREGORY CLARKE, a Licensed Land Surveyor, entitled "FASHION VALLEY NORTH Being a subdivision of that portion of the unnumbered lot also known as Lot 1175 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County, and known as Miscellaneous Map No. 36, said unnumbered lot lying immediately south of Pueblo Lot 1175.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is approved and accepted; and said Council hereby accepts on behalf of the public a portion of Friars Road for public purposes; and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage and sewer facilities

as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated; and that those certain easements for drainage and sewer facilities as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
