BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the petition for the improvement of FAIRMOUNT AVENUE (Extension) between Mission Gorge Road and Twain Avenue under the provisions of the Improvement Act of 1911, consisting of one sheet and filed under Document No. 764990, is hereby granted.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to prepare plans, drawings, typical cross-sections, profiles and specifications for the improvement of FAIRMOUNT AVENUE (Extension) between Mission Gorge Road and Twain Avenue, in the City of San Diego, by grading, paving, installation of curbs, gutters, sidewalks and storm drain facilities, together with estimates of the costs and expenses of such work and to furnish this Council with a description of the district to be included in the assessment for the work and improvements hereinabove mentioned.
