

RESOLUTION OF INTENTION NO. 222163 (R.79-717)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF HUENEME STREET BETWEEN LAURETTA STREET AND MILDRED STREET AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

NOV 6 1978

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street hereinafter mentioned; and in connection therewith require the reservation of certain easements for a portion of Hueneme Street between Laretta Street and Mildred Street in the area covered by such street.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of a portion of Hueneme Street between Laretta Street and Mildred Street, as more particularly shown on Drawing No. 14109-B on file in the office of the City Clerk as Document No. 764963.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."


