WHEREAS, it is appropriate to insure that the above mentioned issue identification reports adequately address the applicable policies of the Coastal Act; and

WHEREAS, the Planning Department has submitted the above mentioned documents to the City Council Rules Committee for consideration, and the Rules Committee has reviewed this material and found it appropriate with respect to implementing the Coastal Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council formally approve the submission to the coastal commissions of the Torrey Pines and North City West issue identification reports, on file in the office of the City Clerk as Document Nos. '765011 and '765012.
