WHEREAS, the State of California has established the California Housing Finance Agency to provide housing assistance to various localities throughout the State via its Home Ownership and Home Improvement Loan Program; and

WHEREAS, The City of San Diego, pursuant to Resolution No. 219760 adopted November 23, 1977, applied for housing assistance with the California Housing Finance Agency on December 6, 1977; and


WHEREAS, the California Housing Finance Agency approved The City of San Diego's participation in CHFA's housing program and authorized \$25 million dollars in loan funds for San Diego for 1978; and

That the City Manager, or his designee, is hereby authorized to submit an application and take other measures as necessary for the City's participation in the CHFA housing program for 1979.
