BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and directed to execute, for and on behalf of The City of San Diego, an amendment to the subdivision agreement for TORREY PINES BEACH SUBDIVISION UNIT NO. 1, to provide for the substitution of PARDEE CONSTRUCTION COMPANY for WILLIAM LYON DEVELOPMENT COMPANY, INC., as subdivider, under the terms and conditions set forth in the Amendment to Subdivision Improvement Agreement for TORREY PINES BEACH SUBDIVISION UNIT NO. 1, on file in the office of the City Clerk as Document No. 765042.

BE IT FURTHER RESOLVED, that Bond No. 400FE1578, issued by ST. PAUL FIRE AND MARINE INSURANCE COMPANY in the amount of \$25,000.00, is hereby accepted as improvement security for the performance of the public improvements. and that Bond Nos. 555 0348 and 555 0353, issued by the AMERICAN CASUALTY COMPANY, are hereby released.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by September 1, 1979, as provided by the amendment to the subdivision agreement.
