

RESOLUTION No. 222212 (R. 79-682)


Adopted on NOV 13 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of MALIBU GRAND PRIX, a California corporation, executed in favor of the City of San Diego, bearing date of March 24, 1978, conveying to said City the permanent easement and right of way for a public street across all that portion of the Southeast Quarter of the Southeast Quarter of Section 1, Township 15 South, Range 3 West, San Bernardino Base and Meridian, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MIRAMAR ROAD.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution attested by him under seal, to be recorded in the office of the San Diego County Recorder.
