

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GRABHORN ENGINEERING CORP. for consultant services in connection with design and improvement of Dairy Mart Road between Beyer Boulevard and San Ysidro Boulevard, for a sum not to exceed \$28,800, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 765018.

BE IT FURTHER RESOLVED, that the expenditure of \$22,000 from Gas Tax Fund 219 and \$6,800 from Capital Outlay Fund 245 is hereby authorized for the sole and exclusive purpose of providing funds for said services.
